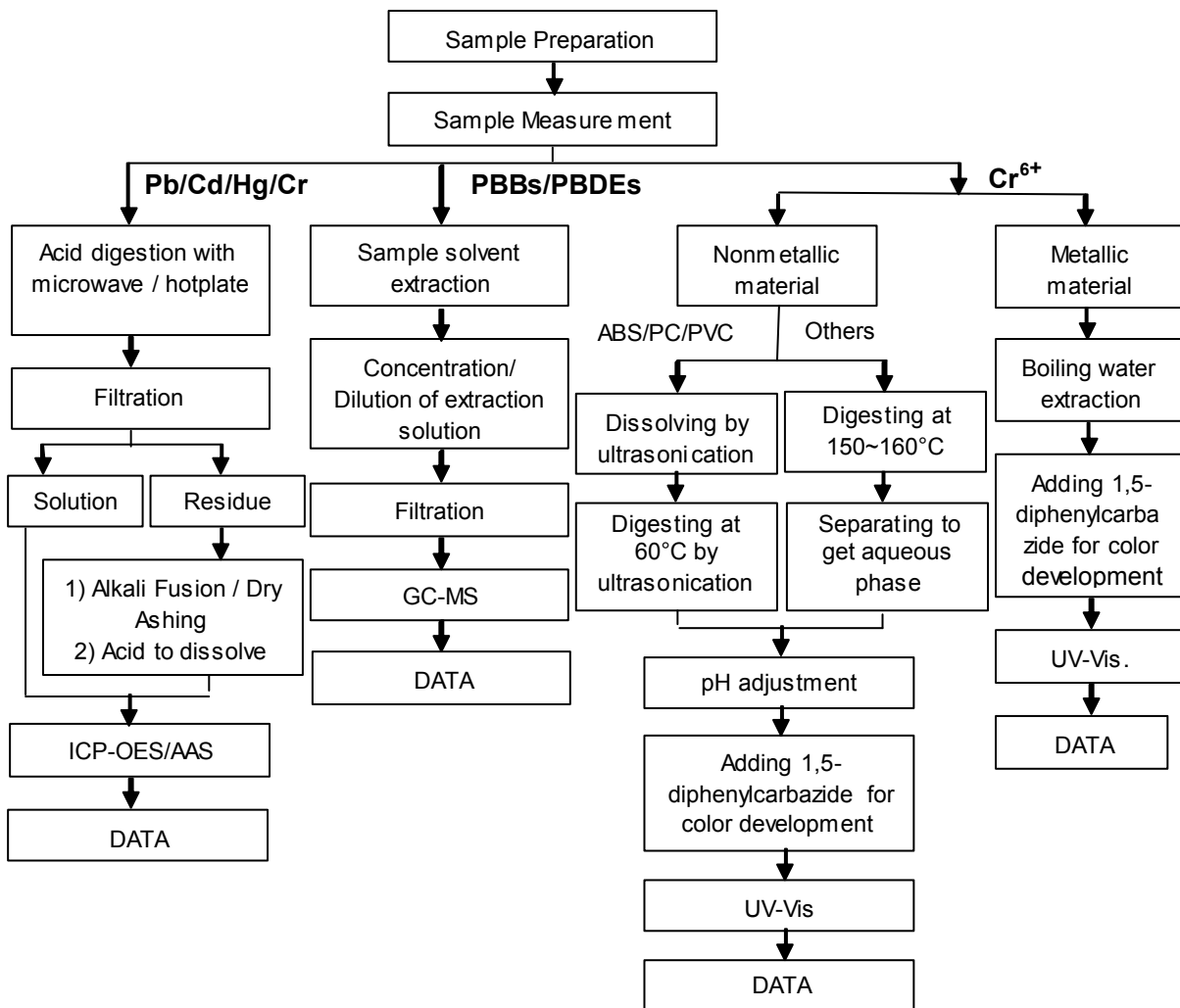

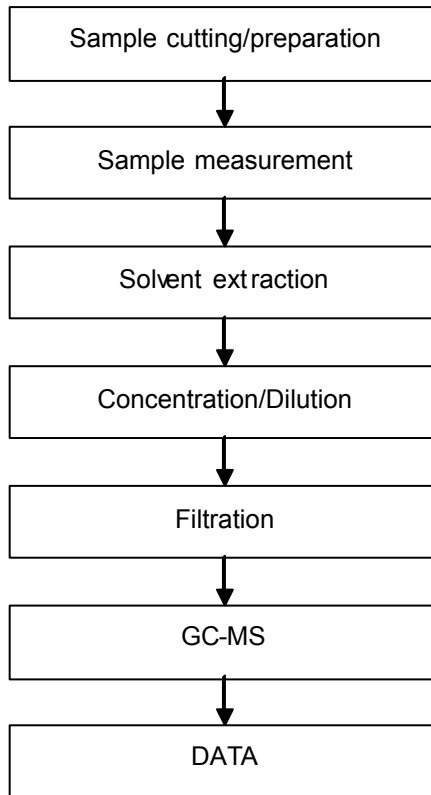

Phthalates Testing Flow Chart

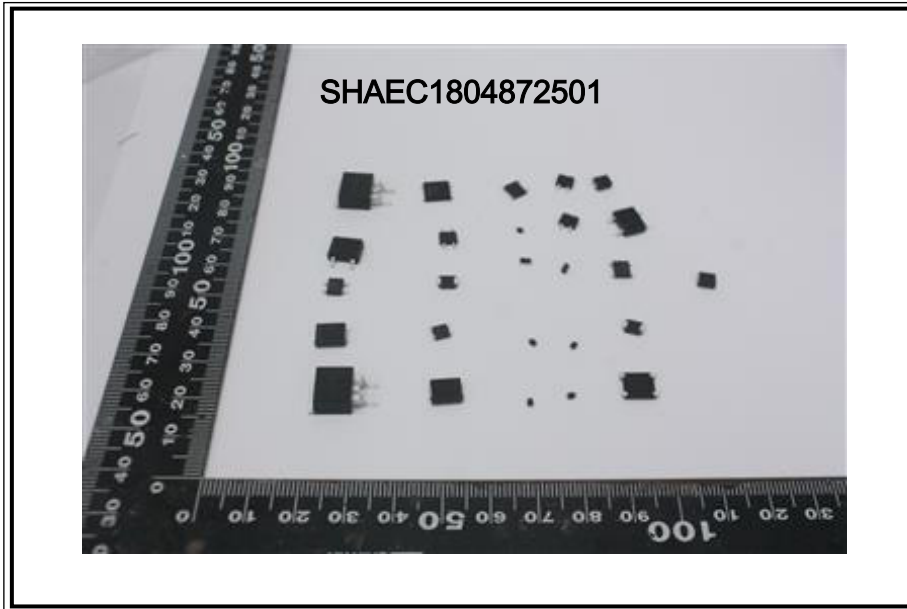
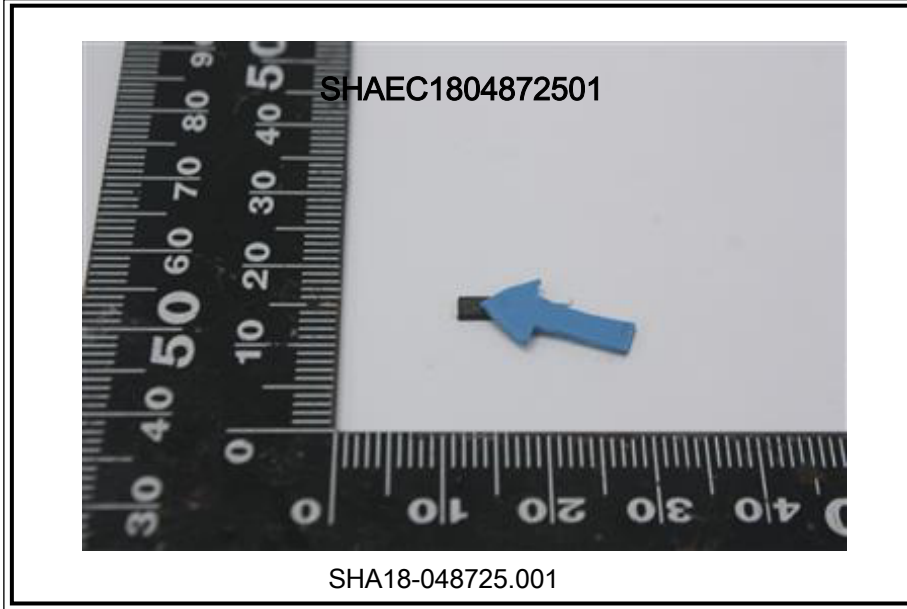

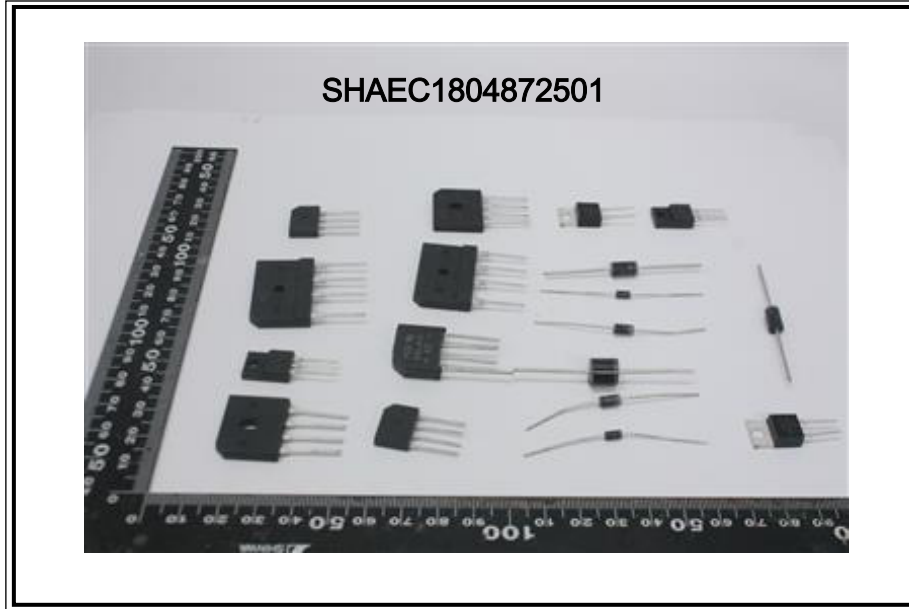
